The SEIU 775 Secure Retirement Plan is the first of its kind in the nation for homecare workers! The goal of the Secure Retirement Plan is to provide additional financial security when you retire. In July 2018, the contribution rate increased from \$0.25 to \$0.50 per qualifying hour<sup>1</sup>. This increase will be reflected on your next annual statement.

This statement reflects your account balance as of the end of the second year of the retirement plan.

- 1. **Total hours reported** Caregiving hours reported for the first two years of the plan. You must report 300 hours per plan year for three years without a permanent break in service<sup>2</sup> to vest in the plan.
- 2. **Status** You vest in the plan after working a minimum of 300 hours each year for three years<sup>3</sup>. To withdraw a benefit, you must be vested and meet the normal retirement age of 65.
- 3. **Prior year-end account balance –** This is your account balance as of the end of the last plan year.
- 4. **Employer contributions** This reflects contributions made under the Collective Bargaining Agreement that apply to you<sup>1</sup>. All plan contributions are solely funded by your employer.
- 5. **Gains** This reflects an increase in your account value due to the investment gains and interest income earned in the plan. Investments in the plan are directed by the Secure Retirement Trustees.
- 6. **Expenses** This reflects a decrease in your account value due to the operating expenses of the plan. These expenses are related to the administration of participant accounts.
- 7. **Year-end balance** This is your account balance as of February 28, 2018.
