This is a summary of the annual report for the SEIU 775 Secure Retirement Plan (Employer Identification No. 47-4321390, Plan No. 001) for the period March 1, 2017 to February 28, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$2,246,448, which were solely for administrative expenses of the Plan. A total of 70,817 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$35,389,246 as of February 28, 2018, compared to \$21,604,946 as of March 1, 2017. During the plan year the Plan experienced an increase in its net assets of \$13,784,300. During the Plan year, the plan had total income of \$16,030,748. This income included employer contributions of \$14,715,991, and net earnings on investments of \$1,314,757.
