

Dear Participant,

SEIU 775 Secure Retirement Plan is the first of its kind in the nation for caregivers. The goal of the Secure Retirement Plan is to provide you with additional financial security when you retire.

When the plan started in March 2016, the contribution received for every qualifying hour was \$0.23. Over time, the contribution grew from \$0.25 to \$0.50 and, as of July 2019, is currently \$0.50 to \$0.65 depending upon your total hours worked over time for your employer.

After studying the plan's experience for the first three plan years, the Secure Retirement Board of Trustees has approved some changes to your plan that went into effect on July 1, 2019, to reduce expenses and improve participant experience. These changes include 3 important improvements for those people who joined the plan before July 1, 2019:

- 1. Automatic vesting Effective July 1, 2019, benefits are 100% vested at all times. This rule applies to you if you have at least 1 hour on or after July 1, 2019<sup>3</sup>.
- 2. More flexible retirement rules that allow workers age 65 and older with \$2,400 or more in their account to receive a **monthly** retirement payout while still working as a caregiver.
- 3. Beneficiary designations The plan now provides that married participants may, with spouse consent, designate a beneficiary of their choosing to receive a survivor benefit.

A permanent break in service occurs after five, consecutive years reporting less than the required number of hours for vesting.
